If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. The minimum average annual financial turnover of the bidder during the last three financial years, ending on 31st March of the previous financial year, should be as indicated in the bid document. The turnover of the bidder shall be validated by the system based on the financial data available on the GeM portal. The average turnover shall be calculated based on the last three financial years where data is available; in case data is available for only two of the last three financial years, the average shall be computed based on those two years. In case the date of constitution / incorporation of the bidder is less than three years old, the average turnover in respect of the completed financial years after the date of constitution / incorporation shall be taken into account for this criterion. No separate documentary evidence is required to be uploaded by the bidder for this criterion, as the system shall derive and validate the turnover figures from the data available on the GeM portal.
6. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity

during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

7. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

8. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

2. Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

5. Generic

Installation, Commissioning, Testing, Configuration, Training (if any - which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.

6. Generic

8. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

9. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

10. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

11. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

12. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

13. **Inspection**

Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before dispatch, the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories testing charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take into account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.

When there is requirement of submission the advance sample, the seller shall inform the buyer promptly through emails about the date of submission of sample to the buyer nominated Inspection agency.

14. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

15. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

16. **Warranty**

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

2. BIDDER SHALL SUBMIT THE FULL BILL OF MATERIAL ALONG WITH TECHNICAL BID.

3. PAYMENT SHALL BE MADE WITHIN 30 DAYS AFTER DELIVERY, INSTALLATION AND GENERATION OF CRAC AND SUBJECT TO SUBMISSION OF GEM INVOICE, SELLER TAX INVOICE, DELIVERY CHALLAN /PACKING LIST,

SUBSCRIPTION / WARRANTY CERTIFICATE, INSTALLATION & COMMISSIONING REPORT, TRAINING CERTIFICATE/REPORT, ORIGINAL CALIBRATION CERTIFICATE, COUNTRY OF ORIGIN VALID PBG AS PER BID/CONTRACT CONDITION ETC.

4. SCAN COPIES OF THE TEST REPORTS / PDI AS PER TEST PARAMETERS SUCH AS GEOMETRIC & ALIGNMENT TESTS, FUNCTIONAL & OPERATIONAL TESTS AND MACHINING & PERFORMANCE TESTS. IN THE NAME OF IDEMI, MUMBAI CONFIRMING TO TECHNICAL SPECIFICATION ANNEXURE-I SHALL BE SENT TO CONSIGNEE FOR VERIFICATION & DISPATCH CLEARANCE.

5. PARTIAL DELIVERY/SHIPMENT OF ITEM NOT ALLOWED.

6. Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. Contract copy along with Unmasked Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed. b. Execution certificate by client with contract value. c. Any other document in support of contract execution like Third Party Inspection release note, etc. Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria: a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed. b. Execution certificate by client with contract value. c. Any other document in support of contract execution like Third Party Inspection release note, etc.

7. Inspection:

1 The Principal Director, IDEMI, Mumbai reserves the option of inspecting the goods by our own representative at suppliers works prior to Packing and Dispatch or by third party appointed by us. However, the supplier should furnish the inspection report of the equipment prior to inspection by IDEMI representative. Supplier shall provide all facilities for carrying out the inspection. However, the final inspection will be carried at IDEMI, Mumbai. Inspection Charts and guarantee certificate of quality should be provided along with the material/part.

2 Within 30 days of receipt of LOA/purchase order/contract, the supplier/ manufacturer shall submit to IDEMI, Mumbai their Quality Assurance plan (QAP)/ GAD/ Foundation Drawings etc for approval.

3 Manufacturer/Supplier, shall give, in writing, at least 10 days' notice to IDEMI, Mumbai to enable it to deputize its authorized representative to witness the inspection of the Machine/ equipment.

4 In case IDEMI, Mumbai decides not to inspect/witness the inspection, authenticated copies of test reports, indicating various test procedures and test parameters, together with permitted values as well as the values actually obtained, shall be submitted to IDEMI, Mumbai for approval. The machine/equipment shall be dispatched only after Waiver of Inspection by IDEMI, Mumbai or obtaining the inspection/test report from the inspecting agency as the case may be.

5 The cost of travel, lodging and boarding of the inspection official shall be borne by the contractor/supplier/manufacturer.

6 In case machine/ equipment fails or is found defective during inspection or machine/ equipment not found ready for inspection at the appointed time, then cost of inspection charges shall be borne by the supplier. In case, if the supplier fails to conduct the inspection of equipment(s) in one go and offered multiple inspections or scattered inspection of equipment(s), then inspection charges shall be borne by the supplier.

7 Bidder should have valid delivery period, approved GAD, QAP, material test reports/ certificates etc in possession at the time of inspection to avoid any delay in inspection of M&P and it is bidder's responsibility to plan the pre dispatch inspection accordingly. Inspection shall be carried out as per approved GAD/QAP at firm's premises.

8. SPECIFICATIONS AND DRAWINGS:

1. Machine/ Equipment shall be built/supplied conforming to the specifications and drawings (if any) indicated in the bid document

2. Successful bidder shall supply all documentation, including Operation a Maintenance manual and "as built" drawings, necessary for operating, maintaining, repairing and modifying the systems and equipment supplied, installed or modified under the Contract

3. The documents and other originals of all records or documents pertaining to the work shall be treated as confidential by bidder and shall not, without consent of the Employer and Client be made available to an

y person and shall be delivered to the Client upon completion of the work.

4. The bidder should submit GAD (Electrical/Mechanical/Civil) of the M&P within 30 days from the LOA for a approval (if any). The drawings should contain complete Bill of Material with technical details.

9. JOINT RECEIPT INSPECTION/COMMISSIONING & FAC:

1. Joint receipt inspection (JRI): - The supplier would be required to carry out joint check at consignee premises along with the consignee, before unpacking is done, to avoid subsequent complaints regarding short shipment/transit damages. It is necessary that this joint inspection be done immediately on receipt of the machine by consignee to avoid commissioning delays due to shortages/transit damages. The joint receipt inspection shall be signed between consignee & bidder/supplier. The supplier /bidder should coordinate with the consignee in advance for receipt of material at their premises.

2. The contractor/supplier or his agent will commission the machine. All commissioning material should be arranged by supplier at the time of commissioning. After installation, commissioning of the equipment Joint Commissioning Note (JCN) shall be prepared and the equipment shall be immediately handed over to consignee representative at site.

3. The machine performance shall be demonstrated by the contractor or his agent after successful commissioning at the consignee's workshop site and prove out the claimed capability, to the satisfaction of consignee. After such successful demonstration, the consignee shall take over and watch the machine performance before the final acceptance certificate is issued. The performance parameter of the M&P, as laid down are achieved individually for 10 days continuously, the plant will be acceptable and Final Acceptance Certificate (FAC) shall be issued by client.

4. Provision of all tools and equipment, technical and skilled & unskilled manpower, material handling equipment and all materials for installation and commissioning by contractor/supplier.

5. If, within two months, after several attempts of rectification one or several of the essential performance data can, in the opinion of the Consignee/MSME, not be achieved and if such shortcoming is not offset by better performance and other essential data, then liquidated damages shall be levied up to a maximum of 05% of the accepted rate of the concerned M&P items.

6. The Contractor shall depute their service engineers for commissioning of machine/ equipment at site/nominated store. All charges pertaining to travel, lodging and boarding of service engineers shall be borne by the Contractor.

7. Final Acceptance certificate (FAC) shall be issued by the consignee/MSME within 10 days from the following date (whichever is later) when:

a) Joint Commissioning Note (JCN) has been issued after installation, commissioning and Proving-out tests carried out and performance values achieved

b) The Contractor has rectified in a definitive manner all defects/ objections/ observations mentioned in the Joint Commissioning Note (JCN), if any.

c) Final documentation incorporating latest modifications has been submitted by the Contractor in requisite copies,

d) The Contractor has met any and all other obligations under this Contract.
