### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

### 4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

- 4. THE PURCHASER MAY DECIDE TO WAIVE PRE-DISPATCH INSPECTION AND AGREE TO ACCEPT MANUFACT URER'S TEST CERTIFICATE AGAINST THE INSPECTION CLAUSE.
- 5. PAYMENT SHALL BE MADE WITHIN 30 DAYS AFTER DELIVERY, INSTALLATION AND GENERATION OF CRAC AND SUBJECT TO SUBMISSION OF GEM INVOICE, SELLER TAX INVOICE, PACKING LIST WITH ITEM DESCRIPTI ON, MODEL NO., SR.
